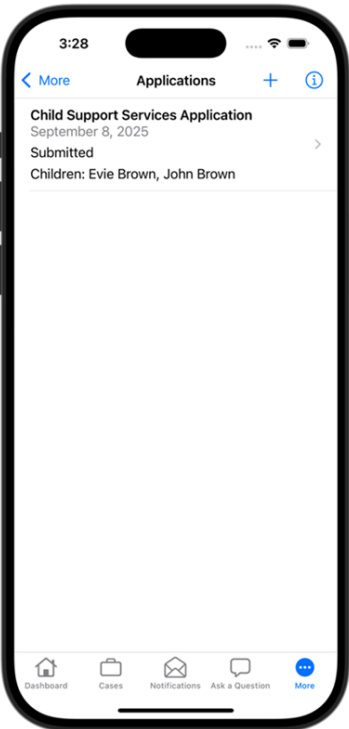

Family Violence (FV)

What is a FV Protected Account?

An "FV Protected Account" is a child support account designed for individuals who have experienced, are currently experiencing, or at risk of experiencing family violence (for example, domestic violence and/or child abuse). An FV Protected Account safeguards sensitive personal information from becoming visible to the other people on your case, or another party.

If you request FV protections it will apply to all case(s) you have with the child support program.
