<b>Communication Center</b>	Allows users to securely exchange messages and supporting documents with states, employers, and the federal Office of Child Support Enforcement (OCSS).	October 2021
<b>Customer Inquiry State Response (CISR)</b>	Allows states to communicate with OCSS regional or central staff regarding child support cases through secure messaging without encrypted email.	September 2020
<b>Data Reliability Audit (DRA) Portal Upload</b>	Allows states to electronically submit Self-Assessment Audit data.	January 2017
<b>Department of Defense (DoD) Entitlement</b>	Provides a breakdown of wages, bonuses and other financial allowances for members of the military.	December 2014
<b>Debt Inquiry Service (DIS)</b>	Provides states with information reported by employers or insurers about non-custodial parents who will be receiving a lump-sum payment from the employer or insurer.	August 2018
<b>Electronic Document Exchange (EDE)</b>	Allows the secure transmission of electronic documents between states and counties.	August 2018
<b>eEmployer</b>	Provides employer contact information and Federal Employer Identification Numbers (FEINs).	June 2012
<b>FCR Misidentified Participant</b>	Allows states to maintain a list of member IDs and misidentified Social Security numbers (SSNs) for their state to ensure that incorrect SSNs are not assigned to case members.	June 2014
<b>FCR Query</b>	Allows users to conduct real-time searches of the Federal Case Registry (FCR).	September 2017
<b>Federal Collections and Enforcement (FCE) - Federal Tax Refund Offset</b>	Provides federal tax refund offset information.	June 2012
<b>Federal Collections and Enforcement (FCE) - Passport Denial</b>	Provides passport denial data.	June 2012
<b>Insurance Match (IM)</b>	Allows states to download Insurance Match Response files.	January 2013
<b>International Forms (iForms)</b>	Allows IV-D workers to generate and download Hague Convention forms in multiple languages for processing international child support cases with participating countries.	January 2024
<b>Intergovernmental Reference Guide (IRG)</b>	Provides information on intergovernmental case processing and contact information for each state.	December 2014
<b>Locate</b>	Provides information from the Federal Parent Locator Service (FPLS) locate sources.	December 2014
<b>Multistate Financial Institution Data Match (MSFIDM)</b>	Provides MSFIDM information and reports.	September 2017

<b>State Profile Administration</b>	Allows states to enter update and delete their contact information on the Portal without a Help Desk request.	December 2020
<b>State Statistical Reporting System (SSRS)</b>	Allows access to SSRS reports on the Portal.	September 2017
