The Hillsdale County Friend of the Court, through its representative, Kandy Hickey, states as follows:

1. This lien results from a child support order, entered on February 21, 1998 by the 1st Circuit Court Hillsdale County, Michigan. This order requires Colleen Bishop, the obligor, to pay periodic child support of which the order is of record in the circuit court named above.
2. As of August 2, 2005, Jane Doe, the obligor, owes unpaid support in the amount of \$1221.93 and this lien amount is subject to an interest rate of 0%. As required by Michigan law, a surcharge will be added to past-due support. Prospective amounts of child support, not paid when due, are judgments and accrue to the lien amount.
3. Pursuant to M.C.L.A. 552.625(c), a lien was placed upon the account of the obligor through National City - Special Services on .
4. Notice of Compliance with the Lien was mailed to the obligor on .
5. The obligor (or interested party) did not request an administrative review or judicial hearing within 21 days.
6. A Notice of Lien and Levy and Disclosure was sent to National City - Special Services on .
7. In response to the Notice of Lien and Levy and Disclosure, National City - Special Services provided an Answer indicating the amount of funds frozen. Further, National City - Special Services indicated it would require a liquidation and pay-in order to sell the securities and pay the funds to the Michigan State Disbursement Unit on outstanding arrears. A copy of the Answer is attached and made reference to.

WHEREFORE, petitioner requests that this Honorable Court issue an order directing National City - Special Services to liquidate the obligor's account up and to the extent of the outstanding arrears owed in this action.
