1. [] John Doe, [] Jane Doe, shall appear in person on June 21, 2005, at the _____ County Friend of the Court office to show cause why s/he should not be held in contempt for failure to comply with the Court's order.

2. If the named party fails to appear, (s)he may be found in contempt and a bench warrant may be issued for her/his arrest. If contempt is found, the Court may apply any enforcement remedy allowed under the Support and Parenting Time Enforcement Act or the Friend of the Court Act.
 - This matter will be heard before a referee. If the referee cannot render appropriate relief, this matter may be taken before the Court for immediate hearing.
3. Either party attending the hearing must:
 - a. Dress in a manner appropriate for a court hearing.
 - b. Not carry any weapons into the courthouse or the office of the Friend of the Court.
