SUBJECT: Service of Process (LSOP) Screen Enhancements in the Michigan Child

Support Enforcement System (MiCSES) for the MiCSES 4.4 Release

PURPOSE:

This Action Transmittal (AT), effective April 13, 2007, describes enhancements to the LSOP screen in MiCSES.

BACKGROUND:

The Michigan Paternity Act, Michigan Compiled Law (MCL) 722.714(10), allows the Department of Human Services (DHS) to file a complaint on behalf of a child being supported by public assistance. When this occurs, the law requires the mother or alleged father to be made a party plaintiff (displayed as the role of "co-plaintiff" in MiCSES) and requires service to both the parent in the home (as a party plaintiff) and the parent living apart (as defendant). Both parents may be in the home, or live outside the home. PA staff must determine the appropriate role for each individual.

In addition, when a child is in foster care or with a third-party custodian, Michigan statutes¹ make both parents liable for the support of the child. If the actions against both parents occur in the same docket, the PA may serve one parent as the defendant and the other parent as the co-defendant.

PA staff track the service of process on the LSOP screen in MiCSES. Prior to the MiCSES 4.4 Release on April 13, 2007, the LSOP screen only tracked service of process for one defendant, even though there can be more than one party on a given case (as in the above two scenarios).

In addition, the LSOP screen had some inconsistencies that made it difficult for PA staff to enter and update information accurately. For example:

- Information did not update properly after PA staff clicked the *Update* button; and
- Error messages displayed at inappropriate times.

PROGRAM ACTIONS AND POLICY INFORMATION:

Effective April 13, 2007, there will be new functionality related to the tracking of service of process on the LSOP screen (Ref: Attachment 1 for a screen print of the new design of the LSOP screen):

A. Service of Process Attempts section: Service Attempt Date field

Title 45 of the Code of Federal Regulations, Chapter 303.3(c) (45 CFR 303.3[c]) requires a state to define diligent efforts to provide service of process to a non-custodial parent (NCP) in a paternity establishment case. In partial fulfillment of these requirements, MiCSES allows PA staff to change the *Service Attempt Date* field only within eight days of original entry. With the MiCSES enhancement, the following system limitations will further enforce this policy:

- 1. When PA staff save the Service Attempt Date, the screen will only be updated if they enter a note. A Note field (free-text field) will pop up on the LSOP screen if a modification of the Service Attempt Date field is attempted.
- 2. When PA staff enter a note, they must:
 - a. Enter at least five alphabetical characters in the Note field; and
 - b. Explain why they modified the date, since the date affects timely service of process.

Note: This explanation is required to provide a history of actions on the case for audit purposes and to track changes in the required timeframes for service of process.

B. Proper display of error messages

MiCSES will follow screen standards for handling errors. The LSOP screen will not display any other messages when PA staff click the *Update* button and the action is successful. Error messages will display at the appropriate times when incorrect actions are attempted (e.g., the user enters fewer than five alphabetical characters in the *Note* field).

C. Service of Process section: new Party field

The Service of Process section on the LSOP screen will have a new field, Party. It will allow PA staff to track service of process for more than one party on the case.

- 1. The *Party* field will feature an initial field for inserting the two-letter role code, and an adjacent field that displays the caption name.²
 - a. The four most frequently used codes (and their corresponding caption names) for serving parties are:
 - i. CD (Co-Defendant);
 - ii. DF (Defendant);
 - iii. PC (Co-Plaintiff); and
 - iv. PL (Plaintiff).
 - b. In addition to the codes above, there are four other *Party* field codes. It is not anticipated that any of these will be used for service of process. These codes (and their corresponding caption names) include:
 - i. 3P (Third Party);
 - ii. CH (Child);
 - iii. GA (Government Agency); and
 - iv. TP (Third-Party Plaintiff).

Note: PA staff must select one of the eight codes to track service of process for each individual party to the case. There can be only one individual for each type of party per case.

- 2. When PA staff double-click the *Party* field, it will display a list of values (LOV) derived from information in the *Legal Case Role Information* field on the *Legal Case* (LCSE) screen.
- 3. Double-clicking on a value will insert the two-letter role code in the *Party* field, and the associated caption name will display in the adjacent field. If PA staff type the two-letter role in the *Party* field, MiCSES will insert the value, if found on the LOV in the field. If the two-letter role code in the *Party* field is not found on the LOV, MiCSES will prevent the PA worker from updating the screen.
- 4. Once PA staff enter or select a value for the *Party* field, MiCSES will display information added for that party in the *Service of Process* and *Service of Process* Attempts sections of the LSOP screen.
 - Note: All PA staff must track the service of process information in MiCSES by individual party on the case.
- 5. MiCSES will create alerts at the court action referral (CAR) level in accordance with the service timelines for the party with an LCSE code and description of "DF Defendant." The system functionality will not create alerts for the service

timelines of the "CD – Co-Defendant," even if the dates of service of process for the defendant and co-defendant are different.

 MiCSES will update an existing LSOP screen for a party when PA staff change information for that party and click the *Update* button prior to selecting a new party.
