The following information explains the fields on the State Verification Exchange System (SVES) Prisoner Information Report.

The date report was generated is in the upper left hand header.¹

TITLE: The type of report being returned. The prisoner information report is titled: *Department of Human Services QN-114 SVES – Prisoner Information.*

SSN: This field shows when the Social Security number (SSN) was used as one of the Business Objects search data, "1" will show if all SSNs were selected, or the default of 0000000.

BIRTH MONTH: This field shows the birth month when the birth month was used as one of the Business Objects search data. "ALL" will show if all birth months were selected. The default value is ALL.

BIRTH DAY: This field shows the birth day when the birth day was used as one of the Business Objects search data. "ALL" will show if all birth days were selected. The default value is ALL.

BIRTH YEAR: This field shows the birth year when the birth year was used as one of

the Business Objects search data. "ALL" will show if all birth years were selected. The default value is ALL.

LAST NAME: This field shows the last name of the person to be located when the last name was used as one of the Business Objects search data. "ALL" will show if all last names were selected. The default value is ALL.

FIRST NAME: This field shows the first name when the first name was used as one of the Business Objects search data. "ALL" will show if all first names were selected. The default value is ALL.

PRISON TYPE: This field shows the prison type when prison type was used as one of the Business Objects search data. "ALL" will show if all prison types are selected.

START DATE: This field shows the start date when the start date was used as one of the Business Objects search data. "ALL" will show if all start dates were selected or if the default of 01-01-0001 was selected.

END DATE: This field shows the end date when the end date was used as one of the Business Objects search data. "ALL" will show if all end dates were selected or if the default of 12-31-9999 was selected.

NAME: Name of the prisoner submitted for the locate request in first name, middle initial, last name and suffix format.

SSN: The prisoner's SSN as reported to SVES by the prison.

MEMBER ID: The submitter's unique identifier for a person who is a participant in a case that is presently on, or is being added to, the Federal Case Registry (FCR), or who is the subject of a locate request.

GENDER: The prisoner's gender as reported to SVES by the prison.

FIPS: The five-digit Federal Information Processing Standards (FIPS) code associated with the prisoner's county code for the jurisdiction responsible for the support order.

DATE OF BIRTH: The prisoner's date of birth as reported to SVES by the prison.

ALIAS SSN (MULTIPLE SSN): Any other SSN provided by the FCR for the locate request.

PRISON NAME: The name of the prison/facility where the prisoner is confined.

PRISON ADDRESS: The address of the prison/facility where the prisoner is confined.

ADDRESS LINE 1: The edited street address supplied by SVES.

ADDRESS LINE 2: The edited street address supplied by SVES.

ADDRESS LINE 3: The edited street address supplied by SVES.

CITY, STATE, ZIP: The city that is associated with the prison facility address; will be blank if not applicable. State and zip code will follow the city name.

CONTACT NAME: The name of the contact person for the prison/facility.

PHONE: The area code and phone number for the prison/facility.

FAX: The area code and phone number for the prison/facility FAX machine. If unavailable, this field will contain spaces.
