SUBJECT: REVISED: *Understanding Child Support: A Handbook for Parents*
(DHS-Pub 748)

PURPOSE:

This Action Transmittal (AT) introduces the revised *Understanding Child Support: A Handbook for Parents* (DHS-Pub 748) (Ref: Attachment 1).¹ The OCS Program Development Division (PDD) has reformatted the handbook and updated it with current program information.

This AT has been updated to include the final hard copy version of the DHS-Pub 748 that includes graphics and Department of Human Services (DHS) punctuation standards. The publication revision date is March 2009. Previous editions may be used with the supplemental page, *Supplement to DHS-Pub 748* (DHS-Pub 748-Supplement).

BACKGROUND:

OCS is responsible for providing information to the public regarding child support services in Michigan. OCS PDD staff designed the DHS-Pub 748 to meet the federal requirements for public information. To comply with Section 45 Code of Federal Regulations (CFR) 302.30 and 45 CFR 303.2, this information must include at least:

- A description of the child support services available;
- An explanation of the individual's rights and responsibilities;
- A list of the support enforcement services available;
- Information about fees related to the child support program;
- Information about cost recovery and distribution; and

- A telephone number or postal address for obtaining further information.

PROGRAM ACTIONS AND POLICY INFORMATION:

Changes to DHS-Pub 748

Federally Required Annual \$25 Fee

The child support program must comply with a legislative requirement to assess an annual \$25 fee on certain cases in which \$500 in child support payments has been collected.² In Michigan, this fee is collected from the custodial party.³ AT 2008-033, *REVISED: Assessment and Retention of the Federal \$25 Annual Fee (FED fee)*⁴ provides policy information on this fee. Information about the fee was originally issued as a supplement to the DHS-Pub 748. This information is incorporated into the new handbook.

Expanded Michigan State Disbursement Unit (MiSDU) Information

Information about child support payment options, payment disbursement options, debit cards, and methods for contacting the MiSDU is included in the handbook.

Customer Rights

The handbook includes information regarding customer rights and responsibilities, and the child support program requirement to provide a Social Security number.

Enforcement Services Available

The handbook provides a more inclusive list of enforcement services available through the child support program.

Additional Changes

The DHS-Pub 748 includes updated information regarding tax refund offset, medical support, contact information and addresses, and Web sites. Also, the handbook is reformatted and reorganized.
